



## ORDINANCE NO.: 2018-4-12

AN ORDINANCE OF THE TOWNSHIP OF MORRIS, CLEARFIELD COUNTY, REPEALING IN FULL ORDINANCE NO.: 2017-9-7, KNOWN AS THE RECREATIONAL VEHICLE SITING AND/OR STORAGE ORDINANCE, REGULATING THE SITING, USE, STORAGE OF RECREATIONAL VEHICLES, REQUIRING PERMITS, AND ASSESSING FINES AND PENALTIES AND AUTHORIZING ENFORCEMENT OF THE SAID ORDINANCE

**WHEREAS**, pursuant to the Second Class Township Code, 53 P.S. § 65101, *et seq.*, specifically chapter 141, the Board of Supervisors is authorized to make and adopt Ordinances necessary for the proper management, care and control of the Township, and the maintenance of the health and welfare of the Township and its citizens, among other things;

**WHEREAS**, pursuant to the Second Class Township Code, 53 P.S. § 66601, the Board of Supervisors may adopt or repeal Ordinances in which general or specific powers of the Township may be exercised, and, by the enactment of subsequent Ordinances, the Board of Supervisors may amend, repeal or revise existing Ordinances;

**WHEREAS**, the Board of Supervisors of Morris Township, Clearfield County, ordained and enacted Ordinance No.: 2017-9-7, on or about September 7, 2017, entitled "Recreational Vehicle Siting and/or Storage Ordinance, giving the same immediate effect; and

**WHEREAS**, the Board of Supervisors of Morris Township, Clearfield County, now determines it to be in the best interest of the Township and its citizens to repeal Ordinance No.: 2017-9-7, in its entirety;




1. Ordinance No. 2017-9-7 entitled "Recreational Vehicle Siting and/or Storage Ordinance" shall be and is hereby repealed.


